VII. The President's Report

President Santmyer: WVU's Internal Senates Liaison Pierce is going to give a lot of the information regarding transformation and the appeals in progress. We also have the first town hall tomorrow if you guys would please try to come and raise your concerns as representatives, or just be there to listen to students tomorrow. Outreach Coordinator Tiano will give more details about that. I think it is really good for us to be there for students and listen to what they have to say, so please spread the word about that. We also have the questions to be submitted for the townhall on our instagram. We are also putting out a survey to get input, the Comms team is working on that as we speak. We all have to stick together during this process. If anyone has any questions, please reach out to me and we can talk.

VIII. Assembly Reports

President Pro Tempore Risk: College Senator Madden and I have discussed creating a Chamber's College Student Advisory Board. Expect more information about that soon. College Senator Coulter and I have been working on a piece of legislation to extend the amount of time you can rent study rooms at the downtown library. Right now the limit is three hours, but we have a meeting on Friday to discuss changing that.

College Senator Oursler: There will be two town halls, one tomorrow and one on September 11th at 7:00pm on Evansdale. These, the surveys, and possible tabling that will occur will be the most important things that are happening in the next couple weeks for everyone to help with and attend. This will help us make very informed decisions when we write the resolution that we hope to have by next week for the first meeting. In the future, we hope to push out any major amendments that may occur based on more information that we gather from this sort of stuff. Anyone who wants to get involved please let any of us involved know. I also want to say thank you for last week. There has been a lot of stuff going around and I appreciate all the support on the resolution last week

X. Executive Reports

Chief of Staff Long: There is still time to Send Silence Packing. I will bump the message for the event we are partnering with the Carruth Center on the main chat. There is one more training on that tomorrow from 5:15 - 6:15p.m. The event will be held all day September 12th, but you can work various shifts that day to accommodate your schedule. It is an event focused around suicide prevention and destigmatizing mental health. We hope you can take part in representing SGA in this event and helping out the Carruth Center.

Apprentice Coordinator Flower: If you haven't filled out the mentor application, please do it now. The application will be closing tonight. I really encourage you to do so, it is a great experience. We have 50 apprentices that we will be taking in, so we do need mentors to place them with. Thank you all for pushing out the application, we had a good turn around for them.

Policy Coordinator Blair: Just a reminder, I am here to help you as you are writing legislation. You can message me in the GroupMe or we can meet somewhere. Let's start out by writing really good and meaningful legislation. If you would like any help, or have any ideas, that is what I am here to help with. Let's also see how we can work with other organizations especially in this time by sharing out resources and not competing for them.

WVU Internal Senates Liaison Pierce: I have not met with the staff senate, they meet every other third Wednesday of the month, once a month. President Santmyer and I met with GPSS President on Thursday August 24th. We discussed Academic Transformation and the impact on graduate students. There are 287 graduate students who will be affected by this process. They are going through a two phase process of sending out surveys and doing grad student outreach. There were 20 responses as of last Thursday, and the second survey is more deliberate data collection. They are hoping to gather feedback from the results when the surveys have concluded. They are reaching out to Associate Provosts Mark Gavin, Evan Widders, and Lou Slimak to receive answers to questions raised about grad students and research integrity during the transformation process. There is a faculty senate meeting on August 28th. On September 6th is the University Assembly Vote. A petition was signed by at least 5 percent of university faculty to vote on two resolutions. The September 6th University Assembly plan on voting on two resolutions at noon. The first resolution is a Vote of No Confidence Against President Gee, and the second is a Motion to Suspend Academic Transformation Process as a Result of Speed of Process. The Appeals process is still underway and ends this Friday. As of Monday August 28th, the Provost heard

a total of 7 appeals. Appeal Results are being released on a rolling basis; results for four appeals have been released thus far (World Languages, the BSR in Recreation, Parks and Tourism Resources in the Division of Forestry and Natural Resources, the BSBSE Biometric Systems Engineering program in the Department of Computer Science and Electrical Engineering, School of Public Health faculty size- 11) World Languages Appeal- Under the recommendation, instruction in Spanish (a high-demand language) and Chinese (a critical need language) would be offered based on student demand and instructional capacity. With faculty reduced to the number of 5. The department did not appeal recommendations to discontinue the BA or MA World Language programs. Majors and minors not viable to pursue. After the appeals process has concluded the BOG will vote on the final decisions regarding reviewed programs on September 15th. As a result of extended attention to program review, academic transformation for ASUs has been delayed. ASU review is the next step in the transformation process. Rob Alsop revealed that 24 million in cuts were achieved for FY 24. Savings stem from college mergers, savings from reduced salary amounts, savings from lessened teaching loads. FY 25 implement a new budget model; hope to engage with campus this fall. Several goals in the new budget model including more transparency and accountability on what drives revenues and expenses. Going forward, the university wants to engage in deep dives into departments and programs every three years to prevent a deficit. We are working on creating a document for relevant questions and answers relating to the transformation process on the SGA website. We will be adding questions from Town Hall this upcoming Thursday, August 31st to the doc. If there are any questions relating to the process after the meeting, email them to me and I'll get a response.

Social Media Coordinator MaGrogan: If you need anything posted or made for the socials, please fill out the google form that I have pinned in the formal chat.

Outreach Coordinator Tiano: Our first townhall is tomorrow in the Mountainlair Ballroom. I would really appreciate anyone who could come out and support, we also have a zoom option. It would be great if you all could repost the graphic and the link to the google form. We are keeping that open on a rolling basis so we can address any questions that we are unable to get to tomorrow, we can get to the town hall on September 11th. We are having the first 30 minutes open to questions and then lead into discussion. We are expecting it to run over an hour. It would also be great if you guys would consider collecting can tabs. I will have

more information on that by the next meeting. If you drink a lot of soda, please start collecting them.

Attorney General Miller: When we are in the middle of debate, you do not have to move to end debate. You may want to if there is debate, and you want to kill the talking. We have the governing documents committee applications coming up. We need three assembly members and one executive. We are trying to get them approved by next week, so please apply by monday. We go over things such as the election code and the constitution. Even if you do not get accepted, you can come in the meetings and give input, you will just not be able to vote.

Special Rules

To better and more efficiently structure the formal meetings of the West Virginia University Student Government Association and the Student Assembly; and,

To allow each and every member of the student body, faculty, staff, and community of West Virginia University an equitable and timely forum to address campus grievances; and,

To ensure that the debate and discussion necessary to the function of the Student Assembly is deliberative and specific;

The Student Assembly of the Student Government Association of West Virginia University hereby adopts the following Special Rules of Procedure, to supplementarily supersede Robert's Rules of Order, Newly Revised:

1. Comments made during Open Student Forums shall be limited to one-hundred eighty (180) seconds in duration per speaker, to be uninterrupted by the Gallery or Assembly, except in cases of Points of Order.
2. Speakers and Petitioners during Open Student Forums shall be granted two (2) recognitions by the Chair per Forum.
3. Open Student Forums are reaffirmed as forums open to petition and recognition by any member of the WVU community, not exclusive to students or members of the Student Assembly.
4. Cell Phone use is generally prohibited during Assembly Meetings, subject to emergencies or other effective uses as deemed pertinent by the Chair. Computers are allowed, should they be used generally for Assembly purposes.
5. These Special Rules of Procedure may be suspended via a simple majority vote of the Student Assembly, either in whole or in part.
