# Presentation of the West Virginia University Annual Sustainability Report, Traci Knabenshue, Director of Sustainability

*Knabenshue*: I am not going to be giving a report, but more so talk about our sustainability goals. We work with all ABS units across the University to set these goals. I focus more on the physical campus goals. All of these are publicly available on STAR. We noticed that we have a low level of awareness across the campus community of sustainability. #### **XIII. Old Business**

#### A. AB-2024-11-02

Elections Chair Coulter explained the bill in lieu of reading it.

President Pro Tempore Olivero: I don't support changing it for the third time in three years. Online voting is impossible for us to get right. We open it up to electioneering and doing it after the campaign hurt the campaign. The absentee ballot didn't work super well even after we sent out the mass email.

Senator Davis moved to open to gallery, seconded by senator street.

Chief of Staff Risk: I do think we equate voter engagement with being involved in SGA. We do represent people who won't be in SGA. Even if that is the only time someone is involved with SGA, their voices are heard. We also did approve a bill that had many statements that were to increase voter turnout. I think that it is super important. The first thing I ever voted on in SGA was elections code changes, and that is the only thing I have not been confident on when voting here.

College Senator Robinson: My question is was there any consideration of doing a hybrid voting system of both in person and online

*Elections Chair Coulter*: We usually don't have enough personnel to run in person voting.

Senator Olivero: Last election cycle, you would be able to post about the absentee ballot and tell people while youre campaigning to request it. I also don't think that people will remember to vote if we eliminate campaigning during the actual election. I'm concerned about having less people tabling during the election. I am also concerned about mass voting from fraternities and sororities.

Senator Street: I don't think we should settle for the ballot to be fairly accessible when we could have very accessible. 800 is not enough. We have the chance to make it super accessible and I think we should take it.

*Senator Vuiller*: Also I think that mass voting from Fraternities and Sororities already happens.

*College Senator Jones*: Fundamentally, this is a question of do we want more or less people voting. The last thing we need on this campus is less representation and involvement.

Senator O'Neal: It is our job to make things as accessible as possible. I've talked to many students and they did not have enough time to vote in the lines. It is our job to make it accessible for them.

*Executive Secretary Orcutt*: I had multiple people from my college, which is underrepresented, telling me they would have voted if there had been an easier way to do it. With this said, I think it it is foolish to vote against a bill that students are basically asking for.

*Sophie Slaughter*: I am pretty engaged on campus, and I am never confident on how to vote and it is still hard to vote. Waiting in line is not feasible for everyones schedule. I rushed through the process. My vote would be more informed if I voted from the couch.

*Segrid*: Voting online would make my life so much easier. I am not on campus outside of class to vote and I don't have time to do it between classes.

*Intern Coordinator Skaff*: Working the polls is hard and frustrating. We don't have enough people to work the polls. Scheduling is a huge issues

College Senator Merlin: HSC is all alone. I didn't even need to run because I knew not enough people would vote for it to matter. We don't ever need to come downtown. Who is even really taking the time to cheat?

*College Senator Morgan:* Many people have had issues getting absentee ballots for the Presidential Election, and they will do the same for the SGA election. I think the online voting will help with SGA elections. A lot of us ran on this platform of visibility

College Senator Magrogan: I think there are really good parts of this bill, I just think that instead of eradicating in person voting, we could make absentee voting more accessible. This is a very controversial subject, but to make things easier for both sides, we could try and come to a compromise. I definitely sympathize with it being hard to get out and vote being from HSC. I see both sides.

#### B. FB-2024-21

A motion to approve the bill was made by College Senator Jones, Seconded by Senator Davis. The bill passed.

Elections Chair Coulter was recognized.

*Elections Chair Coulter:* We amended the bill to include a hybrid method of voting. I emailed the bill to you.

*College Senator Robinson*: This amendment would change my vote to a yes. I think that in person voting is important to the integrity of voting.

College Senator Selders: I agree with Olivia. This is super important for people that are not on the downtown campus. We need to ensure that everyone can vote, even if they aren't down here.

College Senator Lutman: On the ballot, is there going to be a way for people voting online to know who they are voting for?

*Morgan Prunty*: Yes, Thanh and I go in and add in extensive detail all of that information in a drop down box. It is a little question mark right next to the name.

College Senator Mugnano: One of my concerns is the ability of people being able to campaign. I am concerned about people who have no prior knowledge of the candidates voting.

College Senator Silva: This is a valid concern, but I don't think it will make that much of a difference.

*College Senator Jones*: As elected representatives, it is not our responsibility to gatekeep who can vote. Everyone needs to be represented, regardless of their knowledge.

Senator Vuiller: Everyone that votes not, are you completely opposed to vote online or are you okay with the hybrid?

College Senator Madden: I came in with the entirely online voting election. It is more accessible, but it is harder to manage, and that is my main concern. I obviously don't speak for everyone.

The meeting was extended by another 15 minutes.

Senator Vuiller: I hear your concerns, but obviously we had some people come in and speak from outside of SGA, and if the most busy people can't come and vote, those are the people we want to vote the most because they are the most involved on campus. Cutting off that option will be alienating a group of people who are too busy to vote in person or run the polling votes.

*Chief of Staff Risk*: I don't think this online voting system is the same as previous years. This is a pretty good compromise. That year that we are referencing, not everything was going on was related to the elections code. This is also a pretty chill assembly with better vibes.

Senator Olivero: Personally i am against online voting across the board when you are having it when you are not allowed to campaign, because it takes the presence of the campaign away. It doesn't seem to be fair to rely solely on things like social media rather than actual campaign tabling.



President Pro-Tempore Olivero: I disagree. I appreciate that the authors of this bill were willing to compromise and I think the compromise is pretty good.
