**Whereas,** according to Article V, Section III of the SGA Bylaws, the purpose of the Governing Documents Committee is to, "Critically evaluate the relevance and purpose of this organization's governing documents"; and,

**Whereas,** upon evaluation of the SGA Constitution, the members of the Governing Documents Review Committee, collectively voted on the following proposed amendments; and,

**Whereas,** the members of the Governing Documents Review Committee believe the following proposed amendments will enhance the efficiency and effectiveness of the Student Government Association's appointment proceedings,

Therefore, be it enacted by the Student Assembly of West Virginia University:

**Section 1:** The following addition concerning executive appointment procedures set

forth by the Governing Documents Review Committee shall take immediate effect:

Article 4.1 Description shall be amended as:

**4.1 DESCRIPTION.** The West Virginia University Student Government Association Executive Branch shall consist of the President and Vice President, who are elected by the student body during the annual West Virginia University Student Government Association Election. Within three weeks following the SGA Inauguration, the President and Vice President will appoint members to serve on the Executive Cabinet. The President may also have the power to appoint other executive positions as deemed necessary. **Executive appointees may only be nominated for approval of a position once within the same term but retain eligibility to be considered for other positions within the Student Government Association within the same administration.** 

**Section 2:** The following addition concerning executive and legislative vacancy appointment procedures set forth by the Governing Documents Review Committee shall take immediate effect:

Article 10.1.d Vacancy and Succession shall be amended as

10.1.d. If a candidate is appointed by the Student Government Association Select Committee on Legislative Vacancies and Appointments for a position within the Student Government Association but fails to receive two-thirds (2/3) approval from the Student Assembly, they will not be eligible for reconsideration for the position during the same term. However, they remain eligible to be considered for other positions within the Student Government Association within the same administration.

Therefore, be it enacted by the Student Assembly of West Virginia University:

**Section 1:** The following addition concerning transitioning documents set forth by the Governing Documents Review Committee shall be voted on by the student body in the spring election:

Article XII. Transitioning Documents shall be added as:

## **ARTICLE XII. Transitioning Documents**

**12.1 PURPOSE AND SCOPE** This article aims to mandate the timely production of essential transitioning documents by the outgoing administration, ensuring a comprehensive understanding of critical information for the incoming administration.

**12.2 Requirement for Transitioning Documents** The outgoing administration shall prepare and submit detailed transitioning documents on the following key areas:

- a. Elections: Provide recommendations for improving the SGA election process and highlight any complications or challenges.
- b. Legislation with Continued Implications: Summaries of enacted legislation with ongoing ramifications and assessing its effectiveness and challenges.
- c. Unfinished Legislation: Documentation of pending legislative initiatives, their objectives, and the current stage in the legislative process.
- d. Connections: Compile a comprehensive contact sheet including names, titles, and contact information for critical stakeholders for matters pertinent to the SGA.

**12.3 Submission Timeline and Format** The transitioning documents must be submitted no later than the last SGA meeting of the spring semester in a format accessible and understandable to the incoming administration.

## Therefore, be it enacted by the Student Assembly of West Virginia University:

**Section 1:** The following amendments set forth by the Governing Documents Review Committee shall be voted on by the student body in the spring election:

Article 3.1 Shall be Amended as:

**3.1 MEMBERSHIP.** All students registered and enrolled as a full-time at least a half-time student of the Morgantown campus at West Virginia University shall be deemed members of the student body and therefore eligible to participate and hold membership in the West Virginia University Student Government Association. This organization will not discriminate on the basis of age, disability status, ethnicity, gender identity, national origin, race, religion, sex, sexual orientation, or veteran status

### Article 4.2.5i Shall be Amended as:

i. The elections chair must be a full-time student at least a half-time student at WVU who has completed at least one semester at West Virginia University and seen at least one election cycle

Article 6.2.1 Shall be Amended as:

- 6.2.1 JUSTICES. The Judicial Court shall consist of 9 Justices, 1 serving as Chief Justice. They shall consist of:
  - a. Full-time students; Students enrolled at least half-time at WVU;

Article 9.1 Shall be Amended as:

9.1 BASIC QUALIFICATIONS AND REQUIREMENTS TO SEEK AND HOLD A POSITION IN SGA. All SGA positions, whether elected or appointed, shall be open to full-time students any student enrolled at least half-time at WVU who are in good academic standing (cumulative GPA of 2.5 or above) which must be transferred from a BOT recognized institution. To continue to hold an SGA position, the WVU student



must remain a full-time student at least a half-time student in good academic standing. The Dean of Students will have the final decision on questions of status. All appointed positions must be approved by a two-thirds (2/3) vote of the Student Assembly.

Article 10.1.4 Shall be Amended as:

10.1.4 All applicants must meet the requirements to be on the Student Government Student Assembly as outlined in Article 9.1 and 9.2, with the following exemption: First-semester freshman and first-semester transfer students may be appointed to elected positions. These requirements shall be outlined on the application. For vacancies with specific regard to College Senators, applicants must be enrolled in the academic college for which the vacancy has been created.

Section 1: The following amendments set forth by the Governing Documents Review

Article 3.1 Shall be Amended as:

**3.1 MEMBERSHIP.** All students registered and enrolled as a full-time student eligible to hold an elected or appointed position under the SEL policy of the Morgantown campus at West Virginia University shall be deemed members of the student body and therefore eligible to participate and hold membership in the West Virginia University Student Government Association. This organization will not discriminate on the basis of age, disability status, ethnicity, gender identity, national origin, race, religion, sex, sexual orientation, or veteran status

Article 4.2.5i Shall be Amended as:

The elections chair must be a full-time student who is eligible to hold an elected or appointed position under SEL policy and has completed at least one semester at West Virginia University and seen at least one election cycle

Article 6.2.1 Shall be Amended as:

6.2.1 JUSTICES. The Judicial Court shall consist of 9 Justices, 1 serving as Chief Justice. They shall consist of:

a. Full-time students; Students eligible to hold an elected or appointed position under SEL policy

Article 9.1 Shall be Amended as:

9.1 BASIC QUALIFICATIONS AND REQUIREMENTS TO SEEK AND HOLD A POSITION IN SGA. All SGA positions, whether elected or appointed, shall be open to full-time students any student eligible to hold an elected or appointed position under SEL policy at WVU who are in good academic standing (cumulative GPA of 2.5 or above) which must be transferred from a BOT recognized institution. To continue to hold an SGA position, the WVU student must remain a full-time student eligible to hold an elected or appointed position under SEL policy in good academic standing. The Dean of Students will have the final decision on questions of status. All appointed positions must be approved by a two-thirds (2/3) vote of the Student Assembly.

Article 10.1.4 Shall be Amended as:

10.1.4 All applicants must meet the requirements to be on the Student Government Student Assembly as outlined in Article 9.1 and 9.2, with the following exemption:

STUDENT GOVERNMENT ASSOCIATION

First-semester freshman and first-semester transfer students may be appointed to elected positions. These requirements shall be outlined on the application. For

vacancies with specific regard to College Senators, applicants must be enrolled in the academic college for which the vacancy has been created.
