VII. The President's Report

President Santmyer: First of all, I would like to acknowledge that this is a challenging time for our campus community. There is a lot of uncertainty and I know this is difficult for all of us, whether it is the start of classes, uncertainty surrounding potential decisions about academic programs, or just overall concerns. On August 22nd, the Board of Governors held a special meeting. We received an update on the following items: academic transformation, non-academic transformation, and WVU's debt profile overview. The Board approved the Proposed Update Faculty Severance Package Schedule for Clinical Track and Library Track Faculty, as well as endorsing the proposed single unit of the Davis College of Agriculture, Natural Resources, and Design with WVU Extension. Additionally, the Board heard from several students who voiced concerns regarding the preliminary recommendations for Academic Transformation. The Board's next meeting is September 15th which is also when the Board will vote on final recommendations regarding Academic Transformation. Prior to that meeting, the Provost's Office will hold hearings and issue decisions on appeals submitted from 19 of the 25 academic programs that were a part of preliminary recommendations. Let's be clear, the University is facing a \$45 million structural budget deficit. It is non-negotiable that the University must take action to address this crisis, but all of us in this room have a responsibility to speak up and advocate for the priorities of each and every student at WVU. I am very mindful that the most important part of my role is serving as a voting member on the University's Board of Governors. My responsibility as the student voice on the Board is one that I take very seriously. To be the most effective at our jobs, it is vital that we all listen to student concerns. I challenge all of you during these next few weeks before the September 15th Board Meeting to work with Brogan and I to reach students in every corner of WVU to hear their thoughts on this process. We are sometimes going to disagree in our work here, it is bound to happen at some point during this year, and it very well could be at

some point during the next few weeks. My hope is that everyone is respectful and mindful of the fact that each student who is voicing their opinion on this matter is displaying a large amount of courage. We all want what is best for the students of West Virginia University, but we cannot allow any disagreements we may have to become personal and mean-spirited attacks. To all students who have spoken up regarding the Academic Transformation, I promise you that I am listening and that your thoughts, ideas, and concerns are and will be heard. Please know that SGA is here to support you, work with you, and listen to all of your concerns. Vice President Dozier and I worked this entire summer and met with various administrators on priorities for this administration to best support all students during this challenging time. I am excited to work with every single one of you. I have full faith that through our work together we will make this university a better place, and overcome the difficult challenges that we face today.

VIII. The Vice President's Report

Vice President Dozier: Hi everyone! I'm so happy to be back and start getting to work with each and every one of you. Madison and I have been working tirelessly this summer to form relationships to further support you all. We had meetings with the provost, the president, the carruth center, Rob Alsop and many more administrators to fully understand the state of the university and how we could best advocate for the students of WVU. We are exceedingly excited for our upcoming town halls to hear from students, and will continue to advertise our open student forum for student voices. Over the summer I attended my first Alumni Board meeting as a member and continued to express the concerns of the student body. Today college Senator Pillo and I began the process of setting up a joint meeting between the deans of reed and the CCA to fully understand the merger. As a reminder please be respectful tonight and treat others how you wish to be treated.

IX. Q&A With (A) Mark Gavin and (B) Evan Widders

- A. Associate Provost for Academic, Budget, Facilities, and Strategic Initiatives
- **B.** Associate Provost for Undergraduate Education
 - Q: Senator Frazier: How will the academic transformation impact first generation students, and what can we do as SGA members to advocate for the community?

- A: *Mark Gavin:* It doesn't necessarily impact first generation students any more or less than other students. We hope to still have a robust of programs that would be attractive to any students, regardless of background.
- A: Evan Widders: One of our greatest concerns is student success and getting retention in graduation numbers as high as possible. What could happen is that we make certain areas of the university more efficient, with more money to invest in student support. We are starting the REACH center this year with support from a grant, and money from the provost office, to specifically support Pell recipients and first generation students.
- Q: *unknown:* I have heard they are attempting to cut the program (World Languages) because they are attempting to move away from the basic language requirement for certain majors, is that true?
- A: *Mark Gavin:* Yes, that is true. One of the things we are proposing for the language requirement that is attached to the Eberly Bachelor of Arts degree is to eliminate it as a requirement. If the current methodology is upheld, we will be looking for different ways of delivering the language instruction. While it may be delivered through different ways, it is not something we would cease to do. It would just be taken on an elective basis, rather than a requirement basis.
- A: Evan Widders: We are looking into other ways to encourage and facilitate languages as well on campus. Whether it be through badges, or gain courses through other Big 12 schools, it would help us gain access to even courses that we do not offer now.
- Q: Senator Switala: Will there be steps in place to help first generation students who may be affected by these cuts transfer to another university?
- A: Evan Widders: It's not just first generation, it's every single student who is in a major that could get discontinued. That is going to vary a lot and we can not really implement a certain plan now because we do not know if any undergraduate programs will actually be discontinued. But as of now, the plan would be to teach out any student in their junior or senior year, possibly even sophomores, and they could graduate. We aren't required to teach out the degree with the same requirements we have now, so we do have some leniency with course substitutions and credit alternatives. Our most important goals are for students to graduate and to keep their

financial aid. If you are a first time freshman, it would be hard to just teach them out. Fortunately, there's only twenty three first time freshman who have been admitted into a program that could be discontinued. We would hope to be able to find a new home for those students, and if a student wants to transfer we will do our best to facilitate that process.

- Q: *unknown:* What should students in the affected programs expect to see in the upcoming months in regards to their education?
- A: *Evan Widders:* We hope they see nothing. Even if there is a reduction in the program, it won't take place right away. The faculty are still here for the remainder of the year, and a period after that. We will support the teach-outs in those units, but I would not expect to see anything in this academic year.
- A: *Mark Gavin:* In the units that we have recommended reductions in faculty, but not to discontinue the program, we would hope that the impact on students would be very minimal to none. Due to overstaffing in some departments, because of a decrease in enrollment, we are having to reduce the number in staffing to help meet the deficit.
- Q: Senator Sadler: What metrics are the departments being measured by? A lot of students are unsure what grounds to appeal for.
- A: *Mark Gavin:* I encourage you to go to the provost website, and search for the academic transformation section at the top. If you click on it, and drop down on the right hand side, there's a link to the data site that shows the data set we use to conduct our reviews of the programs.
- Q: Student Advisory Boards Liaison Munslow: When considering the World Languages Department, if the discontinuation of the program were to be upheld, and if it is outsourced, are there going to be programs put in place to support the lack of face-to-face programs?
- A: Evan Widders: A teach-out will occur for any of those who are in a major or minor of World Languages. We aren't exactly sure the outcome or what will take place if those programs get cut, considering this will happen two years from now, we hope to have something in place for those students to support their learning.

- Q: Student Advisory Boards Liaison Munslow: Has there been any consideration of cutting some of the smaller World Languages programs?
- A: *Mark Gavin:* We have ideas, but have not defined the range of possibilities. World Languages will be coming to us with a proposal, rather than us telling them this is what they need to do. Our hope is that they come back with such a proposal that we can consider, and I don't know, but I suspect that their appeal will be along the lines of that.
- Q: Senator Leadmon: How do you expect faculty cuts to affect the math Honors Courses?
- A: *Evan Widders:* We would like to see the faculty balanced out between those who teach many classes, and those who do mostly research to be sure they are teaching about the same number of students. We hope this will have no effect on the honors classes, and will definitely have to see how it plays out.
- Q: Senator Olivero: How is what we are doing (academic transformation), compared to other universities in the Big 12? Specifically the foreign language requirement for the Bachelors of Arts?
- A: *Mark Gavin:* We are trying to be transparent about it, while a lot of other universities are dealing with it quietly. Other schools such as Penn State, are dealing with a \$145 million deficit right now and have been on a hiring freeze for at least a year. A school in New Jersey is sitting on a \$70 million deficit that they have to deal with. This is unfortunately a nationwide issue.
- A: Evan Widders: One thing we can say is that we do not believe the answer is to raise tuition. We are not going to do that. That is how some other institutions have worked their way out of such a deficit. I cannot speak to the requirement, but it is very common for Universities to cut their foreign language departments. So much so, it is not reported any more. We would like to work with other Big 12 schools to share resources amongst one another.
- Q: *College Senator Pillo*: With the merging of the colleges, how will this effect students who have the Dean's Scholarship?

- A: *Evan Widders*: It is safe to say that if you currently have the scholarship you will keep the scholarship. In the future, those funds will be ruled into our general funds for any student who wants to come to WVU.
- Q: *President Pro Tempore Risk:* Could we expect more recommendations or cuts for academic programs in the future?
- A: *Mark Gavin:* Generally, no. We want to give the metrics we used this time to the individual colleges in hopes for them to manage themselves. We want to become partners amongst all of the universities. While the review process will continue, and discontinuations are possible, we will not see it on the scale we are seeing it now. If we are successful in making the adjustments that need to be made this time, then the big issues will be mostly handled. Then, it is just a matter of making micro adjustments.

X. Assembly Reports

College Senator Oursler: The Sustainable Land Committee has been hard at work. We have three pollinator gardens on Evansdale currently; one we are still working on. Hopefully by mid-september, there will be some IServe opportunities where you can help us plant in our pollinator gardens. I met with all division chairs and the associate dean in my college, along with students and faculty to get feedback on the proclamation. If there are any wrinkles, we can get them out tonight.

Senator Olivero: Spoke with Traci Knabenshue and Eric Ohara in May. Recycling bill; was told they got a module into NSO and was sent a comprehensive plan for implementing certain programs and initiatives in the fall. Looking forward to seeing how it all pans out and appreciative of everyone's help on that bill.
