## VIII. Old Business

### A. Executive Appointment Confirmation

#### 1. *Lauren Moore, Elections Chair*

*Lauren Moore:* Hi friends! Part two. Lauren does not know what to say differently than last time, but for those who weren't there last week, her name is Lauren. She served as the chief of staff of internal affairs last year, and completed her undergraduate degree in economics, graduating in 2022. Now she is in a master's business data analytics program and runs the TedTalks on campus. A little plug, the speaker applications are due tonight. If anyone is interested, please apply, it is a great time. Anyone who wants to join the student org, lovely time. Lauren also works with Data Driven West Virginia, so if anyone is interested in experience working with data please her know. She loves her job, and she loves talking about it. If anyone has questions, Lauren is happy to answer them.

- College Senator Hudson moved to add College Senator Guschel to the roll via unanimous consent.
- The motion to add College Senator Guschel to the roll was seconded by Senator Amores.
- There were no objections and College Senator Guschel was added to the roll.

*College Senator Neiswonger:* Lauren, can you go into a little bit more for others on why you are qualified for this position?

*Lauren Moore:* Last year, Lauren served as the chief of staff of internal affairs, and with that she got to sit on the Governing Docs Committee as a voting member, so she is very well versed in the governing documents, being the constitution, elections code, and bylaws from last year. Lauren understands that there have been a lot of changes with the elections code this year. With that, she was able to meet with Attorney General Long to go over those and field some questions from some potential candidates now. She was able to meet with the Elections Committee last week, so they've already kind of gotten up to speed and gotten organized with all the documents, filing packets, and planned some really cool educational events. As well as just being a part of SGA and kind of seeing it from the outsider's point of view and the insider's point of view. Lauren thinks that it's really good that she probably wasn't a part of the governing documents' discussions this year, because she can kind of come into them and look at the reviews and see what questions people are going to have. Lauren also has a very logical and technical degree now and is able to parse through data really easily and understand those as well.

**a. Discussion**

*Senator Whalen:* Like she said last week, Senator Whalen thinks that Lauren is super qualified and makes a good point about her perspective of not being on the committee to know what questions to ask. That's really a good asset to have. She's always been kind and friendly anytime she's been around. Senator Whalen knows that she'll do this to the best of her ability, because that's what she did during her last time in SGA.

*Senator Miller:* This past week, Senator Miller heard many divisive comments from members of SGA. Some of his colleagues have called one another cowards. In reality, Senator Miller thinks that many people did not speak up because, you know, fear of being attacked or standing out. Ultimately, he urges everyone tonight to vote how they feel is right and not to succumb to pressure of others. Whether you're for or against this candidate, you should do what you feel is right. Thank you.

*Senator Price:* The issue for Senator Price is that, according to the SGA constitution, the assembly has the power to approve and deny confirmations, thinks in Article Five. Last week, the Assembly spoke loud and clear when it denied the nomination, and of course, was forced into a second vote on it to deny it again. Senator Price does not know exactly what this is leading to the idea that everyone has to keep voting,

and if it's voted down that they're just going to keep being forced to vote until they're subjected to the will of this nomination. Personally, he doesn't think it's right to be continually voting on a nomination that was already voted down. He personally, granted he's not a political science major so you can correct him, but he doesn't know a single legislator in the world that continues to vote on nominations once they've been rejected by the legislative branch. Personally, for Senator Price, for the sake of legislative authority and good governance based upon the SGA constitution, he will be abstaining from voting on this because he doesn't think that they should be voting on something that the assembly has already voted on. Thank you.

*Senator Whalen:* Just a POI. The difference between yays and nays last week was two votes, correct?

*Vice President Uqaily:* Three.

*College Senator Hudson:* It is not lost on College Senator Hudson that about two months ago everyone was sitting here three or four hours from this time, exhausted after having a similarly heated debate on how to reform the election code so that they can meet the moment and ensure that they're not touching these documents, like Senator Price said, that everyone holds dear. For College Senator Price, that means that this is his first time seeing those, and it's really obvious whenever Vice President Uqaily sent those out over the summer that there are issues that needed fixing. That was what was able to be done, to remember correctly, that included a lot of heated discussions, that included one thing that got tabled, a bunch of amendments to it, and eventually a consensus that allowed everyone to reach so that they can meet the moment and actually get these documents in the shape that they need to be so that they can stop touching them and start getting to work on actual things that matter. Part of those changes that were made, though, involved a lot of concessions from College Senator Hudson, fellow senators at health sciences, as well as those in the College of Law. That requires that there are people in place that can actually see to it that the elections code that everyone voted to pass is executed. It's really important to realize that without someone in this position, this election does not happen. Without someone in this position, they cannot uphold the same codes that were voted for.

It's pretty paradoxical and pretty ironic that in the same way that, and he hears what Senator Price is saying, but in the same way, they also voted to uphold these new parts that are part of our documents, and these governing documents need to be upheld. What has been seen is that there is a candidate before everyone

that is undeniably qualified, regardless of whatever your personal decisions are about that candidate, everyone can all hopefully come together and either voice their opinions here in discussion as it's meant to be to come to a conclusion on this, or at least have a better understanding that everyone can all get behind this candidate and realize that for the sake of the election to move forward and for everyone to keep their word that they had negotiated in good faith to get these compromises passed in our elections codes, that everyone vote to actually confirm this nominee. College Senator Hudson would urge all people to vote their conscience, as Senator Miller said, but he also encourages you, if you feel like you can speak up, please speak up. This is exactly what this is for. He would much rather hear grievances here, then whenever they actually go to vote on them. With that being said, College Senator Hudson urges all of you to confirm this nominee.

*College Senator Marquart:* College Senator Marquart had the pleasure of working with Lauren on the TedX executive board, and she is nothing but a good and qualified leader. She would fill this role really well because of her leadership ability and her qualifications are outstanding. There could not be somebody better that could be found for this role. Truthfully, there hasn't been somebody better or they would have appointed an elections chair a long time ago. It's getting really close to the wire and there is a really good candidate before everyone, so College Senator Marquart urges everyone to really consider voting yes for Lauren.

*Senator Volk:* Senator Volk does not know Lauren personally, but she seems very fine and obviously, as she was explaining her qualifications, she's very qualified for this position and has experience with this in the past. Not sure that they're going to find a more qualified candidate at this rate, especially by the time it is needed, which is now. Desperately need an elections chair now; about to have an election.

Based off of last week, Senator Volk was very confused as to how voting turned out. She understands that there may be some concerns as to voting again; however, she was disappointed in the fact that no one had objections last week. Just went straight into voting and so many people voted no, but she didn't understand why. There may be fear of what other people may think about you or say about you if you do have an objection, but as someone who wasn't in SGA last year, if you have a genuine objection to her ability to be able to fulfill this role, Senator Volk would love to hear it. If this is for something petty or something personal, she thinks that you need to rethink your decision as you vote tonight based on what happened last week.

*College Senator Cahill:* College Senator Cahill agrees with everything that was said by those in support of Lauren. It's also very telling about her willingness to do this job and her integrity that she came back here after the vote failed originally. As Senator Volk pointed out, need an elections chair, the candidates information session is tomorrow.

Just want to remind everybody that today is the start of Black History Month, so please, please take some time to read, support, and encourage those to celebrate this month accordingly and beyond. That's really important.

Did want to use advisor privilege and yield the floor to Senator Hodges as he wants to say something.

*Senator Hodges:* First of all, Dr. Le, you came in clutch. Senator Hodges would like to thank you for yielding some of your time. This is a quick meeting and Senator Hodges doesn't want to belabor any of you with a long, agonizing speech. He would just like to say that he is thankful for everything that SGA has given him. But he feels like it was privy to face everyone as he resigns, and not just send an email and not just be scared of the reaction.

As a black man, Senator Hodges feels there's no bigger disappointment than him being a black leader and disappointing his community in this way. But he just needed a break. He doesn't think anybody could understand the burden, the weight, and the pressure that he has put on himself. Nobody has put this on him, and he's just thankful and gracious.

Last semester was really hard, and Senator Hodges had to get medicated, and that's why he couldn't be here. Senator Hodges is grateful for the opportunity and the connections and just seeing all of your beautiful faces as he comes into this room. But he does not have the emotional maturity right now, he doesn't have the patience, and he doesn't have the wherewithal to be in this room anymore.

The best thing that Senator Hodges could give you guys is some advice that was given to him: the weak do not take time for themselves. He just hopes that you guys, as student leaders and as student advocates, take time to yourself. It doesn't matter if you're a college senator, senator, or executive board member, you can lead from anywhere. You don't need this position to lead at all. Senator Hodges wants to lead for his community first and foremost. For Black History Month, he will be very active in his community, and he will be very active in SGA once he gains that competence, but until he does, he will not be here. Hodges out.

*Advisor Le:* Advisor Le and Senator Hodges have been chatting for a while, and Advisor Le's hope is that you all took that seriously, from the sense that you never know what somebody's going through. Don't make judgment on the next person because you think you know what's going on. Time is so short and tomorrow is never

promised, so don't spend your time on negative things, thinking bad things about other people, or making judgments on other people. You know, everyone has lives, and you have no clue what anyone goes home to. Everyone has no clue what you go home to. Judgment is one of the worst things an organization can allow to fester.

*Advisor Prunty:* On a lighter note, sure you guys have seen the emails and the messages in the student org leader GroupMe, if you guys are there. They are doing an Advisor Appreciation Week. Unfortunately, they did have to cut the advisor appreciation breakfast that was done every year. This is their way to show their appreciation and thanks to all of the advisors on campus. If you have an advisor of another organization that really stands out to you all, that you appreciate, please, please, please email SEL at mail with their photo and a little blurb like thank you for working with this organization, for being here for us. Would really appreciate it. Only have two and Advisor Prunty has a whole week of Instagram content to fill. If you have not seen the email or the message in the GroupMe, come grab Advisor Prunty and she is happy to send it to you. She would appreciate it. Thank you guys!
